C) HISTORIC FINANCIAL STATEMENTS -- Submit historic financial statements for the past three years and interim statements dated no more than ninety days prior to application including:

1. Profit and Loss Statements
2. Balance Sheets
3. Cash Flow Statements
4. Disclosure of Contingent Liabilities

D) PROJECTED FINANCIAL STATEMENTS -- Submit three-year projections of the Profit and Loss and Balance Sheet statements. Also, for the first year, include a Monthly Cash Flow Projection statement.

E) DESCRIPTION OF MACHINERY AND EQUIPMENT (If applicable) -- Identify major equipment or classes of equipment to be acquired with the City's funds. For acquisition of new machinery and equipment, attach reliable vendor cost estimates. For moving and installation costs, attach written estimates. For used machinery and equipment acquisition, provide an appraisal demonstrating that the fair market value is in line with the purchase price.
